YARD SIGN LENDING PROGRAM

The program encourages drivers to be more considerate of their neighbors and share the road by bringing more awareness about speeding in our neighborhoods and modifying driver's behavior. The Yard Sign Lending Program reminds drivers to **"Please slow down!"** because **"We all live here!"**.



Prince George's County DPW&T Yard Sign Lending Program provides, for a period up to 30 days, traffic safety yard signs to be installed by community residents in our neighborhoods. Both formal associations and informal groups of neighbors can take advantage of this free of charge program. It is an educational campaign to make our streets safer by posting "Please slow down!" and "We all live here!" yard signs, and organizing other neighborhood and community activities to increase awareness and reduce speeding.

Twenty corrugated plastic signs (10 of each) with appropriate wire stake support units will be available for pick-up by the community president or neighborhood representative at DPW&T's office. The signs should be placed in the residents front yard, behind the sidewalk and always outside the county right-of-way.

The community representative will be responsible for distributing and collecting the material from the neighbors. The signs may be used for a period not to exceed 30 calendar days, at which time the responsible Community President or Neighborhood Representative shall return the material to Prince George's County DPW&T office. The community president or neighborhood representative should call the Traffic Engineering & Safety Division to schedule an appointment to pick-up the material. County staff will work with the neighborhood representative to inform the proper locations for installation, fill out the necessary check-out sheet information and assist with transporting the material to the representative's vehicle.
